## **Guiseley Juniors Non Playing Membership Form - Guidance Notes**

### **Data Protection**

The information provided on this form will be used to administer the football and other related activities of the member. In some cases this may require the Club to disclose the information to the organisations we affiliate with and are governed by such as West Riding County FA, Wharfedale FA, relevant leagues and The English FA itself. In the event of a medical or child welfare issue arising the Club might have to disclose certain information to doctors or other medical specialists and/or the police, children's social care, the Courts and/or probation officers and potentially to legal and other advisers involved in an investigation. ### **Medical Information**
